## Coronavirus (COVID-19) - Reopening Guidance

As the Commonwealth of Virginia begins reopening in phases, so will Louisa County Water Authority. Whether Authority Team Members work directly or indirectly with the public, our jobs are to serve our customers and the citizens of Louisa County.

We developed a Reopening Guidance Memorandum to aid the Authority Team Members in transitioning from COVID-19 Preparedness to our "new normal". The guidance is intended to provide a responsible and safe approach to reopening the business office to serve our customers and the general public.

While still doing our part to reduce the risk associated with the spread of COVID-19, the Authority is making plans to return staffing to 100%. Although titled "Reopening Guidance" the Authority was never officially closed. All facilities and the business office were manned every scheduled day, just with a minimum amount of staff present to meet regulations and the public's needs.

Although the Authority is ramping up to return to a normal work schedule, our number one objective is to protect our staff and the public, to the fullest extent possible, from the risk associated with the spread of COVID-19. The Reopening Guidance will enable required functions and maintenance projects, previously put on hold, to move forward with a full on-site staff.

We appreciates everyone's patience and ask that you continue to bear with us as we navigate these uncharted waters. We encourage folks to continue conducting Authority business by phone, mail, email or through our website. If you visit our business office you will be required to wear a face mask. All business transactions will be conducted at the front counter. Meetings will require an appointment with all personal hygiene protocol measures having been implemented.

We will continue to implement best practices to minimize risk of spreading COVID-19, including:

- Wash hands often with soap and water for at least 20 seconds.
